To all Texas Boxing Clubs:

If you would like for your boxer to enter the State Silver Gloves this year, I must have the *ENTRY FORM* and *MONEY ORDER* (together) and back to me by **December 4th, 2021**. PLEASE DO NOT FAX OR EMAIL!!!

Bantam (8), Juniors (9-10), Intermediate (11-12) & Seniors (13-14) will box three 1-minute rounds and (15-16) will box three 1-½ minute rounds. All ages will have a 1 minute rest between rounds.

Females will be admitted at the same weights as male boxers.

PLEASE NOTE: On Thursday, Dec 16th, there will be a sign-in sheet for the teams and it will be a first come first serve. There will be a mandatory meeting at 3:00pm. At that time, you will find out who will compete that night.

The cut-off date for all ages will be January 1st, 2022.

Example: If your boxer is 8 years old now but on January 1st, 2022 will be 9, then he will box in the 9-10 year old bracket. If he is 16 years old now, but will be 17 years old on January 1st, 2022, then they cannot compete in the State Silver Gloves. However, if your boxer turns 17 on January, 2nd 2022 they *can* compete in the State Silver Gloves.

There will be 2 coaches per team or 4 coaches for 7+ boxers (all boxers must be present). Any other coaches will have to pay. **If you are going to officiate, you cannot coach.** You must have your red book in hand with registration for 2021.
